TOUR PRICE & PAYMENT

Land content only: \$3950.00 AUD per person, based on twin share/double accommodation

Note: Land only arrangements, as set out below in "Tour Price Inclusions".

Single supplement: \$950.00 AUD per person. If you wish to occupy a room alone, please specify on your booking form. In that case, the Single Supplement will be payable.

First Deposit: \$1000 AUD per person, non-refundable, payable within seven (7) days of booking application confirmation. The First Deposit is non-refundable, unless specifically stated otherwise in these Terms & Conditions. A **Second Instalment of \$1475 AUD per person** is due two months later (by 31st March 2024), then a **Third Instalment of \$1475 AUD per person** is due on 31st September 2024.

Final Payment of Balance: due in full (including Single Supplement if requested) by 31st September, 2024. Any bookings made after this date must be paid in full upon booking. On receipt of your Final Payment (and once minimum group numbers has been reached), you will receive detailed pre-departure information to help you plan your trip.

CANCELLATION POLICY

Booking Cancellation Policy: A French Journey will not refund a First Deposit following any cancellation by you of your booking. If you cancel after the Second Instalment is paid, but not less than 45 days prior to the date of travel, a cancellation fee of 60% of the full Tour price will apply. A cancellation made by you less than 45 days before the date of travel will incur a cancellation fee of 100% of the full price. Cancellations must be made in writing. No refunds will be issued if you fail to join your Tour, or if you choose not to participate in any Tour activities that form part of the Services described in “Nature of Our Services” below. For the comfort and safety of all our guests, A French Journey reserves the right to decline to accept or retain any person in the Tour group at any time.

Tour Cancellation policy:

Every endeavour is made to ensure the advertised tour takes place but if the minimum number of guests is not reached at least 60 days before the tour commencement date, that tour will be cancelled. However, in such an event, we will refund in full all payments made by participants to us under these Terms & Conditions (including the First Deposit). The Tour Itinerary is valid for the period specified, but may be subject to last-minute alterations depending on changes to circumstances and operational conditions at the time.

NATURE OF OUR SERVICES

A French Journey offers the service of:

- Providing you with a Tour Itinerary, and either supplying the activities, meals and beverages indicated on that Itinerary, or acting as agents to book them with other providers, where specified on the Itinerary. However, please note the Itinerary may be subject to last-minute changes, as described above.
- Providing accommodation at our Villa near Porto Vecchio, Corsica, France
